The Health care professional will take care about detailed instruction of the patient including possible side effects of this drug.

Before patients are treated with the above mentioned product they have to be informed about the risks involved, and have given written or properly documented oral **Informed Consent** to be treated with above product.

I the undersigned herewith certify, that I am aware of the fact that the above mentioned Experimental Medicinal Product is an **unregistered drug for** compassionate used on named patient basis.

Legally adequate patient insurance exists for each individual patient receiving above mentioned product. Such insurance covers any harm or damage that could arise out of any use of the above mentioned product.

The ordering medical doctor, pharmacist or hospital is licensed to practice in the country, state, or other applicable jurisdiction. Lamprene™ will be used only as directed by physician and only by the person for whom it was prescribed.

In this regard, client understands and assumes responsibility for the fact that some medication sold outside the United States, or other country from where the client is ordering, may be sold under a different brand name and packing insert may be in a foreign language.

Client also understands that products may contain different colourings or inert ingredients such as binders and fillers that could cause an adverse reaction for people with allergies or sensitivities to small amounts of starch, sugar, lactose, peanut or other extracts and other ingredients.

MD's/Pharmacist's license to practice is approved by DocCHECK™ prior to order, or a copy of the professional license to practice is sent along with order .

Due to legal regulations in Switzerland we have to require an original medical prescription issued by ordering medical doctor if medicine is sent directly to patient.

The MD or health care professional acknowledges and agrees that it is his/her responsibility that his/her patient has regular physical examinations including all suggested testing to ensure patient can safely take the requested medications without complication.

The MD is aware of the possible side effects of prescribed product (Lamprene™). It is the medical doctors responsibility that his patient uses LAMPRENE™ under his guidance.
